Subject: Data update on DPC Module of DGHRD – reg.

Please refer to above subject. As you are aware for monitoring DPCs for Group B & C posts at CCA level, DGHRD has developed 'DPC Module' which is functional since 2019. All CCAs updating the date of DPC in this module with some basic details. DGHRD is mandated to monitor the progress and time to time remind various CCA regarding timely update of data on DPC Module. In this regard, kindly refer to this office letters F. No. 8/B/64/HRD (HRM-II)/2017 dated 10.12.2020, 25.08.2021 and reminder letter dated 01.10.2021, 03.11.2021, 16.12.2021 & 04.02.2022.


2. Kindly find enclosed latest status as available on DPC Module as on 05.05.2022 (enclosed as Annexure-A). The data indicates that DPC meetings for promotions to several posts have not been conducted for year 2022 or data has not been uploaded in DPC module by CCA. As per model calendar of DPC for vacancy year, DPC meetings should be conducted in advance. Since we are already in month of May; in all possibility DPC would have been conducted; however data is still not uploaded.

3. It is therefore requested that the requisite details in respect of DPC meetings held so far for current vacancy year, may be filled-in and uploaded on the 'DPC Module'. Also all CCAs may check status of DPC conducted for last vacancy year (2021) and if some data is not updated kindly update the data on the basis of DPC conducted for vacancy year 2021. In case DPC meetings could not be held due to some reason the same may be indicated (as the provision for such remarks is already made available in the Module).

4. All CCAs are requested to do needful and submit a report by 31.05.2022 to the effect that DPC data upto 30.04.2022 has been updated on Module.
