Please refer to the Board's letter F.No. CBIC-3/28/2022-Ad-IIIB Section-CBEC dated 05.07.2022 on the above-mentioned subject requiring information regarding recruitment schedule for PR quota vacancies and quarter-wise details for filling up of vacancies and the report submitted by the CCAs to Board (copy enclosed).
