Subject: Grant of Financial Assistance for Preventive and Welfare measures for fighting against COVID-19 in CBIC-reg.

Please refer to this office letter dated 02.04.2020 on the subject-mentioned above.

2. Financial assistance amounting to Rs. 5.25 crores was disbursed from the Welfare Fund vide Sanction Order No. 1/2020-21 dated 17.04.2020 to 372 Commissioners/ HoDs for Preventive and Welfare measures for fighting against COVID-19 in CBIC, to help the employees as well as prepare the workplace to fight the menace of COVID-19 so as to ensure seamless functioning of all the formations CBIC for continued supply of essential goods & services in the country and providing critical support to the taxpayers.

3. As part of the efforts of the Board to promote the welfare of staff and ensure the seamless functioning of the formations of CBIC the Governing Body of the Customs & Central Excise Welfare Fund has sanctioned the 2nd instalment from the Fund as financial assistance to the formations under CBIC. The amount sanctioned is as under:

- Rs. 3,00,000/- for Customs Commissionerates;
- Rs. 2,00,000/- for GST Commissionerates; and
- Rs. 1,00,000/- for Directorates (per HoD).

A circular conveying the terms & conditions for utilization of the assistance has been issued vide letter of even number dated 23.02.2021 separately.

4. It is important to inform that in terms of the approved scheme, the 2nd instalment of the financial assistance shall be released only to those formations which have completely utilized the earlier sanctioned amount and have submitted the requisite utilization certificates in this regard.

5. It is observed that most of the formations have either not utilized the disbursed amount or have failed to submit the Utilization Certificates (UCs) even after extensions in timelines to submit (UCs) and repeated reminders from this office. Out of 372 afore-mentioned formations only 22 formations (**Annexure-A**) have completely utilized the financial assistance and have submitted UCs and 54 formations (**Annexure-B**) have utilized major portion of assistance and have less than Rs. 1,000/- balance amount to be spent. However, 296 formations (**Annexure-C**) have either not utilized assistance altogether or have major portion left to be utilized or have failed to submit the UCs.


All Zonal Pr. Chief Commissioners/ Chief Commissioners/ Pr. Directors General/ Directors General are once again requested to submit a consolidated Commissionerate-wise utilization certificates of sanctioned COVID-19 assistance in respect of their Zones in the prescribed proforma by **1st March, 2021(positively)**.

6. The 2nd instalment is presently being released to formations listed in Annexures 'A' & 'B' which have either completely utilized the financial assistance or have less than Rs. 1,000/- left to be utilized and have submitted the UCs in this regard. The 2nd Instalment shall not be released to formations figuring in Annexure - 'C'. They are urged to completely utilize the financial assistance and submit UCs by 1st March, 2021(positively) to avail of the 2nd instalment. No further extensions shall be allowed beyond this date.

7. The utilization certificates in respect of the 2nd instalment (and balance amount of 1st instalment in respect of formations listed in Annexure-B) is to be submitted within 6 months of the release of the assistance. The Chief Commissioners/ Directors General are therefore requested to closely monitor the scheme so that the funds granted are utilized judiciously, effectively and timely and ensure that the requirements of field formations and individuals are promptly met.
