**Sub: Grant of Financial Assistance for Prevention and Welfare measures for fighting against COVID-19 in CBIC-reg**

Madam/Sir,

The Schemes for Grant of Financial Assistance for Prevention and Welfare measures for fighting against COVID-19 amounting to Rs 5.96 crores (Ist Installment) & 7.53 crores (2<sup>nd</sup> & 3<sup>rd</sup> Installment) were approved by the Governing Body of the Customs & Central Excise Welfare Fund with effect from 01.04.2020, 10.02.2021 & 02.06.2021 respectively. The same were to be released in three installments on the condition that the earlier installment has been utilized or the un-utilized amount is less than Rs.1000/-.

2. Under the aegis of this scheme, the first installment was of an amount of Rs. 2.25 lakhs per Customs Commissionerate, Rs. 1.5 lakhs per GST Commissionerate and Rs. 75,000/- per Directorate. Further, the second and third installments were of Rs. 03 lakhs per Customs Commissionerate, Rs. 2 lakhs per GST Commissionerate and Rs. 1 lakh per Directorate to be released on the condition that either the earlier installments have been completely utilized or the un-utilized amount is less than Rs.1000/-.

3. In this regard, this is to state that this office has not received the utilization certificate of the **second installment funds** from the Commissionerate/Directorates listed in the **Annexure**. Accordingly, it is requested to kindly ensure that these Commissionerates/ Directorates under your jurisdiction utilize the said funds (if required) latest by **31<sup>st</sup> March, 2023** and submit the following details regarding utilization/surrender of the said funds to this office @ [dgwelfare.cbic@gov.in](mailto:dgwelfare.cbic@gov.in) by **15<sup>th</sup> April, 2023**.
